**STIPULATION AND AGREED ORDER RESOLVING CLAIM
OF QUALITY INSPECTION & CONTAINMENT, INC.**

The CEP Liquidating Trust, as successor in interest to the above-captioned debtors-in-possession, (the "Trust") and Quality Inspection & Containment, Inc. ("QIC") hereby stipulate as follows:

RECITALS

1. On September 20, 2006, Debtors filed with this Court its voluntary petitions for relief under Chapter 11 of the Bankruptcy Code (the "Petition Date").

2. On November 20, 2006, QIC filed a proof of claim asserting a general unsecured claim against the Debtors in the amount of \$13,557.45 at Claim No. 220 (the "QIC Filed Claim").

3. On October 10, 2007, the Trust filed the Second Omnibus Objection to Claims (Docket 712) (the "Omnibus Claims Objection"). In the Omnibus Claims Objection, the Trust objected to QIC Filed Claim on the basis that the Debtors' books and records reflected a reduced obligation to QIC as of the Petition Date.

4. QIC has provided evidence supporting the QIC Filed Claim in the full amount of \$13,557.45.

5. The Trust and QIC have agreed to the following treatment of the QIC Filed Claim under the terms set forth below.

STIPULATION

6. The QIC Filed Claim shall be allowed in its entirety.

7. The Trust shall withdraw the Omnibus Claims Objection with respect to the QIC Filed Claim.

8. Each person proposing this Stipulation represents that he or she has full authority and capacity to make the commitment contained in this Stipulation.

WHEREFORE, the Court finds that good cause exists for approving the settlement of the parties as contained in this Agreed Order.

IT IS, THEREFORE, ORDERED THAT:

1. The QIC Filed Claim is hereby allowed in its entirety.
