**ORDER GRANTING THE CEP LIQUIDATING TRUST'S
SECOND OMNIBUS OBJECTION TO CLAIMS**

THIS MATTER having come before the Court on the CEP Liquidating Trust's Second Omnibus Objection to Claims (the "Objection"), which requested, among other things, that the claims specifically identified on the exhibits attached to the Objection be disallowed in their entirety, reclassified and/or reduced as noted in such exhibits; and it appearing that due and proper notice and service of the Objection as set forth therein was good and sufficient and that no other further notice or service of the Objection need

be given; and it appearing that the relief requested on the Objection is in the best interest of the Debtors, their estates, the CEP Liquidating Trust, as successor in interest to the Debtors, (the "Trust") and creditors and other parties-in-interest; and after due deliberation thereon good and sufficient cause exists for the granting of the relief as set forth herein,

IT IS HEREBY ORDERED ADJUDGED AND DECREED THAT:

1. The Objection is GRANTED.
2. The Claims identified on Exhibit A – No Liability (Books and Records); Exhibit B – Insufficient Support; Exhibit C – Paid Claims; Exhibit H – Late Filed Claims; as attached hereto and incorporated herein, are forever disallowed in their entirety.
3. The Claims identified on Exhibit D – Reclassify, are reclassified in their entirety, as attached hereto and incorporated herein.
4. The Claims identified on Exhibit E – Reclassify, Reduce and Allow; and Exhibit F – Reduce and Allow, are reclassified, reduced and allowed as attached hereto and incorporated herein.
5. The Claims identified on Exhibit G – Redundant Claims, as attached hereto and incorporated herein, are treated as follows: (i) the Claims identified under the heading of "Claims to be Expunged" are forever disallowed in their entirety; and (ii) the Claims identified under the heading "Surviving Claim" remain as claims against the above-captioned estates subject to further defense or objection of the Trust.

7. The Claims identified on Exhibit K – Duplicate Claims, as attached hereto and incorporated herein, shall be treated as follows: (i) the Claims identified under the heading of "Duplicate claim to be Expunged" are forever disallowed in their entirety; and (ii) the Claims identified under the heading "Remaining Claim" remain as claims against the above-captioned estates subject to further defense or objection of the Trust.
