**ORDER GRANTING MOTION OF LIQUIDATING TRUST FOR ORDER  
(I) APPROVING FINAL DECREE CLOSING CHAPTER 11 CASES  
AND (II) GRANTING CERTAIN RELATED RELIEF**

Upon the motion (the "Motion") of the CEP Liquidating Trust (the "Liquidating Trust") for entry of an order approving a final decree closing the Bankruptcy Cases<sup>2</sup> and granting certain related relief; it appearing that the Court has jurisdiction over this matter pursuant to 28 U.S.C. §§ 157 and 1334; it appearing that this proceeding is a core proceeding pursuant to 28 U.S.C.

§157(b)(2); it appearing that venue in this District is proper pursuant to 28 U.S.C. §§ 1408 and 1409; it appearing that notice of the Motion and the opportunity for a hearing were appropriate and that no other or further notice need be given; the Court having considered the Motion; it appearing that the relief requested in the Motion is in the best interests of the Debtors' estates, their creditors and other parties in interest; and after due deliberation and sufficient cause;

IT IS HEREBY ORDERED that:

1. The Motion is approved in its entirety as set forth herein.
2. The Court hereby enters a final decree for all of the Bankruptcy Cases.
3. The Bankruptcy Cases are closed.
4. The Liquidating Trustee is authorized to terminate the Liquidating Trust.
5. The Liquidating Trust is authorized to donate remaining proceeds of the CEP

Liquidating Trust, after payment of all other obligations of the CEP Liquidating Trust under the Plan, to a food bank in Akron, Ohio that is a charitable organization exempt from Federal income tax under Section 503(c)(3) of the Tax Code.

6. The Court shall retain jurisdiction with respect to all matters arising from or related to the implementation of this Order.
