**ORDER APPROVING APPLICATION OF U.S. BANK NATIONAL ASSOCIATION, IN  
ITS CAPACITY AS TOPrS INDENTURE  
TRUSTEE, FOR PAYMENT OF TOPrS INDENTURE TRUSTEE FEES  
(TOPRS TRUSTS I, III AND V)**

Upon consideration of the Application of U.S. Bank National Association (“U.S. Bank”), in its Capacity as TOPrS Indenture Trustee, For Payment of TOPrS Indenture Trustee Fees [ECF No. \_\_\_\_] (the “Application”), and upon consideration of any and all objections and responses, if any, filed regarding the Application; and the Court finding that (i) it has jurisdiction over this matter pursuant to 28 U.S.C. § 157 and 1334 and relevant provisions of the Plan and Confirmation Order; (ii) this is a core proceeding, pursuant to 28 U.S.C. § 157(b)(2); (iii) notice of the Application and the hearing was sufficient under the circumstances; (iv) the TOPrS Indenture Trustee Fees are “reasonable,” as such term is used in section 1129(a)(4) of the Bankruptcy Code; and (v) upon the record herein; and after due deliberation, good and sufficient cause exists for the relief requested;

**IT IS HEREBY ORDERED THAT:**

1. The Application is GRANTED.

2. U.S. Bank's TOPrS Indenture Trustee Fees (including the fees and expenses of its counsel, Shipman & Goodwin LLP ("Shipman")) are allowed in the amount of \$245,885.29, comprised of: (a) with respect to U.S. Bank: (1) \$5,805.00 in fees and expenses during the Prepetition Period; and (2) \$92,379.50 in fees and expenses incurred during the Postpetition Period; and (b) with respect to Shipman: (1) \$10,453.99 in fees and expenses during the Prepetition Period; and (2) \$137,246.80 in fees and expenses during the Postpetition Period.

3. The Reorganized Debtor shall, as soon as practicable, pay the TOPrS Indenture Trustee Fees to (or at the direction of) U.S. Bank, in full, in cash.

4. This Court shall retain jurisdiction with respect to all matters arising out of or related to the implementation of this Order.
