1. The Application is GRANTED.

U.S. Bank's TOPrS Indenture Trustee Fees (including the fees and expenses of its counsel, Shipman & Goodwin LLP ("Shipman")) are allowed in the amount of \$234,670.46, comprised of: (a) with respect to U.S. Bank: (1) \$5,224.50 in fees and expenses during the Prepetition Period; and (2) \$81,922.67 in fees and expenses incurred during the Postpetition Period; and (b) with respect to Shipman: (1) \$10,453.99 in fees and expenses during the Prepetition Period; and (2) \$137,069.30 in fees and expenses during the Postpetition Period.
- 3. The Reorganized Debtor shall, as soon as practicable, pay the TOPrS Indenture Trustee Fees to (or at the direction of) U.S. Bank, in full, in cash.
- 4. This Court shall retain jurisdiction with respect to all matters arising out of or related to the implementation of this Order.
