




The fiscal year 2010 Personal Property Tax bill is based on an assessment made as of January 1, 2009, became due on July 1, 2009, and delinquent as of February 1, 2010. As to this account, claimant claims base tax in the amount of \$19.58, plus statutory monthly interest and penalties at the rate of 20% per annum accounting from February 1, 2010 for aggregate interest and penalties to the petition date, September 21, 2010, in the amount of \$2.61 for an aggregate prepetition claim in the amount of \$22.19. From October 1, 2010, interest accrues at the statutory rate of 8% per annum on the amount of \$19.58 in the monthly amount of \$0.13 per month until the tax is paid in full.


