Exhibit "1"

1. On September 20, 2010 (the "Petition Date"), Urban Brands, Inc. et. al., (collectively the "Debtors") commenced the above styled bankruptcy case by filing a petition or petitions for voluntary relief under Chapter 11 of Title 11 of the United States Code, 11 U.S.C. §§ 101 et seq., in the United States Bankruptcy Court for the District of Delaware.

2. Prior to the Petition Date, Lennox National Account Services, LLC f/k/a Industrial Building Services, LLC ("Lennox") furnished labor, services, materials and/or equipment ("Goods and Services") to one or more of the Debtors on an open account. The Debtors were subsequently invoiced for the Goods and Services but failed to pay for same, resulting in an unpaid balance of \$138,775.59 ("Unpaid Balance") due Lennox by Debtors. A spreadsheet detailing unpaid invoices that reflect the Unpaid Balance is attached hereto as Exhibit "A" respectively and is incorporated herein by reference for all purposes.

3. As of the Petition Date, the outstanding amount due to Lennox for the Goods and Services totaled no less than \$138,775.59, excluding interest, attorneys' fees and/or other fees, charges or costs recoverable as the case may be and to the extent provided by law.


