EXHIBIT "A"--PROOF OF CLAIM

3. That the consideration of this liability is as follows:

(a) By Lease dated June 19, 2002, Claimant, as Landlord, leased unto Debtor, as Tenant, certain premises situated in space #TC-12, Cross Creek Mall, Fayetteville, NC. The term of said Lease commenced on November 1, 2002 and was to end on January 31, 2013. The Lease obligated Debtor to pay minimum annual rental of Seventy Nine Thousand Two Hundred Ninety Six and 00/100 Dollars (\$79,296.00) for years 1-3, Eighty Six Thousand Eight Hundred Forty Eight and 00/100 Dollars (\$86,848.00) for years 4-7 and Ninety Four Thousand Four Hundred and 00/100 Dollars (\$94,400.00) for years 8-10, during each year of the lease term, payable in equal monthly installments, in advance, on the first day of each month of said term, plus a certain proportionate share of the cost of maintenance of the common areas of the shopping center, a certain proportionate share of the property taxes levied or assessed against the shopping center, and a certain proportionate share of the cost of insurance on the shopping center, all as additional rent.

(b) The Trustee of Debtor's estate has not surrendered possession of the leased premises.

(c) At the time of the filing of the petition in this case, Debtor had failed to pay installments of rent and other charges under said Lease, accruing prior to said date, totaling Sixty Thousand Six Hundred Eighty Three and 78/100 Dollars (\$60,683.78).

(d) The Lease has not been rejected by the Trustee of the Debtor's estate. Claimant will be injured by such rejection in the amount which represents the greater of one (1) year's base rent and charges, or 15% of the amount of rent reserved by said Lease for the remainder of the Lease term not exceeding three (3) years.

(e) As to Five Thousand Three Hundred Forty Eight and 43/100 Dollars (\$5,348.43), Claimant is entitled to the priority granted by 11 U.S.C. 507 as an administrative expense, such amount being the fair and reasonable value of the Trustee's use and occupancy of the leased premises during the period between September 21, 2010 and January 22, 2011.

This accrual will continue at Five Hundred Fifty Seven and 72/100 Dollars (\$557.72) per diem for use and occupancy until Lease is rejected by Trustee or Court Order. At time Lease is rejected claim will be amended and priority claim increased to coincide with rejection date.
