TO WHOM THIS MAY CONCERN:

On April 29, 2011, the Illinois Department of Employment Security filed a pre-petition claim for \$2,108.36 covering the period first quarter 2010 through third quarter 2010. The claim was received by the Court on May 9, 2011 per copy of enclosed POC. However, when we inquired from the Court's Claim Registry on PACER, there was no record of receiving the claim filed by the Illinois Department of Employment Security.

This letter was prompted by the receipt of ADP letter dated June 10, 2011 (copy enclosed) specifying that POC documents were sent to their Office for processing. However, they were unable to process the documents as they could not identify information to verify the client or they do not handle these type of documents.
