**PLEASE TAKE FURTHER NOTICE THAT ANY CLAIMANT THAT IS REQUIRED TO FILE A PROOF OF CLAIM IN RESPONSE TO THE SCHEDULE AMENDMENT, BUT FAILS TO DO SO BY THE AMENDED SCHEDULE BAR DATE, SHALL BE FOREVER BARRED, ESTOPPED AND ENJOINED FROM ASSERTING SUCH CLAIM AGAINST LARGE APPAREL OF NEW JERSEY, INC. IN AN**

**AMOUNT, NATURE OR CLASSIFICATION DIFFERENT FROM THAT IDENTIFIED  
IN THE SCHEDULE AMENDMENT.**
